2. Prior to the actual convention we will provide you with the final Layout of the exhibit hall. The order of booth assignment will be based on the date of receipt of the executed contract and full payment for the space. First come, first served. Corporate sponsors receive first choice.
3. Exhibit booths will be available for exhibitor set up Saturday, May 15, at 8:00 AM. The exhibits will open at 11:00 AM Saturday and close Sunday at 11:30 AM at which time tear down and move out will begin. During exhibit hours, only those attendees wearing appropriate Identification badges will be allowed admittance to the exhibit hall.
